The following documents herein attached rebuts and objects to any and all claims of Leon Siu and Ke Aupuni o Hawai'i, and **HEREBY** Objects to all alleged claims therein.

The de jure Interim Provisional Government Council (Privy Council) of the Kingdom of Hawai'i has authorized Henry K. J. Tripp, *Minister of the Interior* to file and record the attached documents for the Public Record, the documents are true and correct and are filed and recorded in good faith.

Notice of Objection Order to Cease and Desist

WHEREAS, the Kingdom of Hawai'i in exile, by and through the Privy Council of the Interim Provisional Government for the Kingdom of Hawai'i, hereby gives this NOTICE OF OBJECTION to "Leon Siu" and to "Ke Aupuni o Hawai'i's" impersonation of Council and any false claim of authorship of Privy Council's signed and sealed "Position Paper With Authorities" dated June 20, 1994, and as thereafter amended only as to form on August 23, 1998;

WHEREAS, Privy Council of the Kingdom of Hawai'i Interim Provisional Government was formed, duly appointed, and accredited to engage in activities and actions related to the reinstatement of the Nation of Hawai'i in accordance with Privy Council's "Position Paper With Authorities", and as officially recorded in the Bureau of Conveyances, in Honolulu, Hawaii, and as designated in said office as *Document No. 94-101968*;

WHEREAS, at no time was there any authorization, permission, grant, license, approval, sanction, or consent from the Kingdom of Hawai'i and the Privy Council of the Interim Provisional Government Council allowing anyone to impersonate a duly appointed member of Privy Council, to counterfeit any Council members official seals, or to make misrepresentations that they were or are an author of Privy Councils Position Paper With Authorities;

WHEREAS, each member of Privy Council of the Interim Provisional Government Council of the Kingdom of Hawai'i have been duly appointed and have accepted the rights and obligations of their respective office, have their own official seal, and have credentials that were served upon the proper diplomatic offices of foreign nations;

WHEREAS, at no time did Privy Council of the Interim Provisional Government for the Kingdom of Hawai'i authorize, convey, or grant any permission, license, approval, sanction, or consent to anyone not duly appointed and authorized as a Minister of said Privy Council to act as or pretend to act in the character and capacity of any duly appointed and authorized Minister, or to use or to assert claim of any right to the official seals and acts of any Minister's offices;

WHEREAS, Privy Council for the Kingdom of Hawai'i, after proper proceedings and consideration, filed and recorded its findings, decision, and supporting documents in the Bureau of Conveyances where said findings and supporting documents are officially recorded as Document *No. 96-003455*. Said recorded findings and decision as against "Ke Aupuni of Hawai'i", and "Lindsey L, Lindsey", justly follow and are properly applied to any representation or later action of "Ke Aupuni of Hawai'i", Lindsey L, Lindsey, and any successor, member, agent, or representative thereto;

WHEREAS, between the months of September and December in 2010, and during the Aha Kānaka Kū'oko'a meetings regarding the reinstatement of the Nation of Hawai'i, one Leon Siu stated to duly appointed and authorized members of Privy Council for the Interim Provisional Government Council for the Kingdom of Hawai'i, that he was (1) a member in "Ke Aupuni of Hawai'i", (2) was the Minister of Foreign Affairs of the Kingdom of Hawai'i, and (3) that his position and authority arose out of the "Position Paper With Authorities" as officially recorded in the Bureau of Conveyances, in Honolulu, Hawaii, as Document 94-101968;

WHEREAS, the duly appointed and accredited Minister of Foreign Affairs of the Privy Council of the Interim Provisional Government for the Kingdom of Hawai'i is Russell Stewart, who personally signed and put his seal upon the "Position Paper With Authorities" as officially recorded in the Office of Bureau of Conveyances in Honolulu Hawaii, and designated as Document 94-101968. As the duly appointed Minister of Foreign Affairs of the Privy Council of the Interim Provisional Government of the Kingdom of Hawai'i, Russell Stewart has publicly appeared and spoken at numerous public meetings and official proceedings regarding the reinstatement of the Nation of Hawai'i;"

WHEREAS, Leon Siu has never attended and did not and does not participate in the proceedings, studies, papers, reports, resolutions, communications and dialogue with other public offices, or in any other functional activities of the Privy Council of the Interim Government for the Kingdom of Hawai'i;

WHEREAS, Leon Siu, while acting as a member in Ke Aupuni of Hawai'i, was cordially and privately asked not to make false representations of authority and fraudulent impersonations as to being the duly appointed and qualified to be the Minister of Foreign Affairs of the Kingdom of Hawai'i, and futher was asked not to make such false claims under pretense of this Privy Council's "Position Paper With Authorities";

WHEREAS, it has come to the attention and knowledge of this Privy Council that one Leon Siu has willfully made further and intentional misrepresentations that he is the duly appointed and authorized *Minister of Foreign Affairs* of Privy Council of the Interim Provisional Government Council for the Kingdom of Hawai`i; that he has authority to use and claim the use of the official seal of the said Office of Foreign Minister, that the letters of credence filed with foreign diplomatic offices are related to him, and that he claims authorship and other official rights and duties as proclaimed in Privy Council's "Position Paper With Authorities";

WHEREAS, by making the aforesaid fraudulent representations and by impersonating the Minister of Foreign Affairs of the Kingdom of Hawai`i, Leon Siu and others did and could intentionally mislead other people and political authorities about his falsely claimed position and authority as Minister of Foreign Affairs of the Kingdom of Hawai`i, the source of said impersonated authority, the rights and duties of the said Minister of Foreign Affairs, and could and probably will make statements and misrepresentations that are wholly outside of and contrary to the "Position Paper With Authorities" and the fundamental principles upon which it rests.

CEASE AND DESIST

THEREFORE, *Leon Siu and Ke Aupuni o Hawaii is hereby ORDERED to CEASE AND DESIST all misrepresentations of character, capacities, authority, and other activities as a member in the Privy Council of the Interim Provision Government of the Kingdom of Hawai`i, and that Leon Siu lawfully derives his authority as the Minister of Foreign Affairs from the "Position Paper With Authorities" as signed, sealed, and recorded in the Bureau of Conveyances as Document No. 94-101968, and as filed in and properly lodged with public offices, departments and agencies in the State of Hawaii, the United States of America, and elsewhere,*


Leon Siu and Ke Aupuni o Hawai`i are individually, personally, and collectively directed to Cease and Desist from using the name and pretext of authority of being the interim functional or recognized Kingdom of Hawai`i, Hawaiian Kingdom, Government of the Hawaiian Islands, or Nation of Hawaii, in the Hawaiian language, English language, or any other language, and more particularly in any public forum, meeting, or symposium, or in any State, Federal or International venues or proceedings.

THIS CEASE AND DECIST IS EFFECTIVE IMMEDIATELY UPON SERVICE
